



NUREMBERG: JUSTICE IN THE AFTERMATH OF THE HOLOCAUST

Over 60 years after the Allies established the International Military Tribunal to try Nazi leaders for their roles in the systematic murder of millions of people during the Holocaust and Second World War, the Nuremberg trials stand as a watershed moment in the ongoing pursuit of international justice. The United Nations' declarations on genocide and human rights, Canada's Charter of Rights and Freedoms and the International Criminal Court at the Hague all reflect principles established at Nuremberg. The *Nuremberg* exhibit traces the history of the trials, highlighting their accomplishments, controversies and legacies, and considers human rights issues that demand response and resolve from the international community today.

MOCK TRIAL SCHOOL PROGRAM

The exhibit provides a backdrop for an optional school program in which students participate in a mock trial of Julius Streicher, the publisher of the virulently anti-Semitic newspaper *Der Sturmer*. In 1946, Streicher was convicted of "crimes against humanity" for his role in inciting the persecution and murder of Jews through the dissemination of hate propaganda. Using primary source material as evidence, students will role-play Streicher's trial, learning about the Nuremberg tribunals' processes and contemporary significance.



BOOKING INFORMATION

EXHIBITION CONTENTS

The exhibit consists of sintra panels and banners which can either be wall mounted or suspended from the ceiling. Also included in the exhibit is a PowerPoint slide show projection depicting images of Julius Streicher and the Nuremberg trials.



Mock trial materials are available on a CD or downloadable from the VHEC website (www.vhec.org). They include two PowerPoint slide shows for use by docents, a Teacher's Guide, including pre and post-visit materials, student role sheets and discussion questions. A docent script is available upon request.

Additional Components: Educational resources are available for reprint, including digital files for a Teacher's Guide, docent scripts and publicity materials. An exhibit poster is also available to be reprinted for promotional purposes.

ONLINE EXHIBIT

An online application of the exhibit is available on the VHEC website and includes educational support material, primary documents, classroom discussion questions, extension activities and recommended resources.



SPACE REQUIREMENTS

The exhibit requires approximately 90 linear feet and includes:

- 8 large sintra panels (3' x 3')
- 10 small sintra panels, each measuring 8.5" x 11"
- 5 banners, each measuring 4' x 5'
- 3 banners, each measuring 2' x 6'
- 1 banner measuring 2' x 2'
- Digital Materials include a CD containing the Exhibit PowerPoint slideshow, two docent Powerpoints and teaching guide (all are also available online).
